Call to Order/Establish Quorum

A regular meeting of the Upper Clear Creek Watershed Association was called to order at 8:30 am by Chair Kerry Major on February 10, 2022. A quorum was declared established.

Agenda Approval

Water Quality Incident Reports

• On Friday, January 21st at 4:00 PM Jeffcom 911 gave notice of a vehicle crash into clear creek, highway 6 at mile marker 264. There was no spill.

Presentation

• Young Ranch Research Quarry – (Bob Young, Young Ranch) A background on the Ranch and their concept to support maintenance of the Central City Parkway through a construction quarry that would provide an income stream for continued maintenance. They are looking to eliminate the 8% grades. Quarry contours would mirror existing contours of the area at a 2:1 slope. Have done studies on revegetation that would blend back to reforestation based on hillside locations. Conducted wildlife study that included the quarry permit area and 6.5 miles of Young Ranch Parkway frontage. Design includes a Parkway offramp, a Parkway underpass, and a Parkway onramp. Ridge remains in place to shield quarry from recreationists, wildlife viewing, and serves as a wind buffer. Working with Central City to pay road fee that goes into a fund to pay for Parkway maintenance. Anticipate finishing the DRMS review process in the next couple of months then they will submit into the local process. They anticipate the property will be annexed into Central City which will take approximately 6 months. They anticipate the quarry itself will function for 80 years and involve approximately 335 acres over the life of the project.

UCCWA approved including the Matrix Study data. The agreement has been signed allowing them to add the Pre-Fire Study data to this larger risk assessment data set.
