Upper Clear Creek Watershed Association Meeting Minutes June 9, 2022

Call to Order/Establish Quorum

A regular meeting of the Upper Clear Creek Watershed Association was called to order at 8:05 am by Acting Chair Ben Moline on June 9, 2022. A quorum was declared established.

Agenda Approval

It was moved and seconded to approve the agenda with addition of a small grants discussion; motion carried unanimously.

Approval of Minutes

It was moved and seconded to approve the minutes of the May 12, 2022 UCCWA meeting; motion carried unanimously.

Secretary/Treasurer Report

The following invoices were presented for approval: Kielty Diversified Projects Invoice #545 for \$750.00 and Clear Creek Consultants Invoice #2558 for \$300.00. Total invoices for payment, \$1,050.00; motion carried unanimously.

Secretary/Treasurer asked the Budget Committee (Ben Moline, John Curtis, and Pat O'Connell) for a discussion on the contingency refund policy.

Referrals

• None received.

Water Quality Incident Reports

None received. There was discussion on the call-down system and communication between the
three counties. There is a gap between Jeffco and Clear Creek County. A prompt request has
been made to Jeffco.

Presentations

• CDPHE TMDLs & Projects Update – (Barbara Bennett, CDPHE Restoration and Protection Unit) They will be developing TMDLs in Clear Creek Watershed next year. This presentation provides background information. Presentation is available by request and was recorded.

Other Business

Standing Items:

- LRE Regulatory Bulletin (Jessica DiToro) The update was provided in the agenda packet. There
 are links in the update if you would like to learn more. Regulation 85 control limits for
 wastewater facilities was discussed. The voluntary incentive program is an opt in program to
 submit total phosphorus and nitrogen. There is a credit system assigned to this program.
 UCCWA is presenting the Annual Report to the WQCC this year. Need an UCCWA
 volunteer.
- Clear Creek Watershed & Forest Health Partnership Update (Diane Kielty) MOU has nine confirmed agencies signing. Once signed they will go forward with a COCO agreement to begin administrative functions. Molson Coors did not sign on to the MOU due to governance

issues for a private company to sign MOUs with government entities. Kielty Diversified Projects will be supporting the WSRF grant effort in crafting draft scopes of work for priority projects.

• Integrated Watershed Management Plan (Ashley Giles) – No report.

There was a small grants discussion about the purpose of the small grants fund and refining the criteria. The idea is to tighten up the criteria to focus specifically to improve water quality. The fund is not intended to pay fines but could help plants find ways to come into compliance. This review will include reconsideration of eligibility requirements. The committee will present a formal proposal on ideas for criteria structure.

There is a request from Jefferson County for a grant for their annual Clear Creek clean-up event in the canyon in September 2022. Additional funds would be helpful. This is to improve water quality and water quality awareness. It was suggested this is more of a donation than a small grant request. The amount is under \$2,000. The request falls under the current ideas of the program. This request would not fall under any new criteria. This event is within our boundaries.

Ben Moline made a motion to donate \$1,000.00 from the Contingency Fund to the Jefferson County Clean-up event and second by John Curtis; 1 nay from Georgetown, 1 abstention from Jefferson County. Motion passed.

The CC40 Gage will be discussed at the next regular UCCWA meeting.
