# Upper Clear Creek Watershed Association Meeting Minutes December 10, 2020

## Call to Order/Establish Quorum

A regular meeting of the Upper Clear Creek Watershed Association was called to order at 8:37 am by Chair Ben Moline in GoToMeeting December 10, 2020. A quorum was declared established.

## **Agenda Approval**

It was moved and seconded to approve the agenda as presented; motion carried unanimously.

#### **Approval of Minutes**

It was moved and seconded to approve the minutes of the November 12, 2020 UCCWA meetings; motion carried unanimously.

## **Secretary/Treasurer Report**

The following invoices were presented for approval: Kielty Diversified Projects Invoice #493 for \$900.00, Clear Creek Consultants Invoice #2395 for \$175.00. The invoices were within the budgeted/approved limits. It was moved and seconded to approve the invoices for payment totaling \$1,075.00; motion carried unanimously.

### **Water Quality Incident Reports**

#### **Other Business**

- Mighty Argo Update A Geotechnical Report is being asked of the applicant. Site approval will be conditional based on report to demonstrate feasibility that groundwater discharge design requirements will be met.
- Pre-Fire Study: Colorado Forest Action Plan Clear Creek County materials were provided in the meeting packet.
- Call Down Committee Update. A list was provided from Jane Thomas with the Clear Creek County Sheriff's Department to update the list. There is a call down gap with the Jeffcom dispatch call down. They broke their dispatch into the divisions. Jeffcom now has separate fire, police and sheriffs dispatch as well as a dispatch that works with the State Patrol. They have not determined how best to address the gap to ensure all people are getting the appropriate conditions information. They are reviewing their logistics to address this issue. Entities need to get on each county's lists. The user will need to reach out to each county. UCCWA may consider developing a joint communication for all the counties and determine the best procedures / protocol to notify users. The process is not clear.

Action: Committee is currently Ben Moline, Jim Ford, Kim Kellerby and includes Andy Cross from Westminster. Brad Benning will contact Gilpin County departments to identify additional Gilpin participants for the Call Down Committee.

Action: Secretary/Treasurer send Clear Creek call down list out to members and Standly Lake Cities.

### **Member Updates**

• There is a \$100M renovation taking place at Coors Brewery. Parking lots are being replaced with new infrastructure and filtration. Water will be captured off rooftops where steam from brewing can release contaminants. This capture will be treated before going back into Clear Creek. They are also building a large culvert along the east side of Ford street to capture 100-year flood flows.

- CDOT has several new projects. They would like to provide an update to UCCWA in January or February.
- The Clean Water Certificate (CWC) training program for workforce development provides high quality training opportunities that promotes job growth in the stormwater industry and delivers industry-specific, job-readiness skills and knowledge.
