Water Quality Incident Reports

• On May 16, 2023, at 1500 hours, the Eisenhower Tunnel Water Treatment facility reported an unknown contaminant with an odd color and odor of an unknown amount entering the waterway. Tunnel personnel will be testing the water for glycol and will update if contamination is confirmed. There are three major projects currently underway by CDOT at the tunnel. The testing was negative for glycol. It may have been an asphalt product. They are still investigating.

• On June 7th, 2023, it was reported that an unknown amount of diesel fuel, possibly as much as 150 gallons, spilled into Clear Creek at mile post 216 on interstate 70 in Clear Creek County.
