Call to Order/Establish Quorum

A regular meeting of the Upper Clear Creek Watershed Association was called to order at 8:31 am by Chair Kerry Major on October 13, 2022. A quorum was declared established.

Referrals

• Field House Private Lift Station Clear Creek County, Diamondback Engineering & Surveying The question of emergency backup power was fielded by the proponent at the Idaho Springs presentation. They do not have an answer to this need currently. UCCWA has until November 14, 2022, to respond.

Other Business

- UCCWA Letter of Support for Clear Creek County USDA Forest Service Community Wildfire Defense grant application was approved and sent to Clear Creek County.
- Clear Creek County Call-Down List Update (Lisa Leben) Suzanne Boccia will be the Clear Creek County call-down list lead. Golden dispatch moved into Jeffcom. Notifications are made to respective systems and those centers are to contact the other systems when call-downs come in. This step should be added to the checklist for the system. The Jeffcom system has a very limited list. The larger list has been truncated. The Jeffcom call-list needs to add Clear Creek and Gilpin. Entities lower entities in the watershed would like to have the full contact list to ensure ditch companies and others are informed. Flush out old list and compare to new list and locate new contacts. Ben Moline confirmed Jeffcom tests their system. UCCWA members Ben Moline, Brad Benning, along with Shelley Stanley, City of Northglenn, will communicate with jurisdictions to ensure call-down systems are in contact.

Action: UCCWA contact the offices of emergency response in each county and invite to present at UCCWA.

Action: Ben Moline will send Jeffcom contact person to Lisa Leben for Suzanne Boccia with CC dispatch. Lisa Leben will get Suzanne Boccia's contact info to Shelley Stanley and Andy Cross for invoicing on call-down.

Action: Shelley Stanley volunteered to take the new list and compare to old list. This will be brought back to group and be cleaned up to provide to Jeffcom.

Action: Create process and contact diagram for UCCWA reference.

- 2023 Budget Committee Update (Pat O'Connell) Committee is continuing to review and by the November meeting will have suggestions to bring to the members.
- 2023 Nomination Committee Update (Ben Moline) Brad Benning has agreed to continue to as Chair and Geoff Niggeler is standing for Vice-Chair.
- 2021 Annual Report presentation to the Water Quality Control Commission December Meeting will be virtual only on Dec 12, 2022 at 9:00 am. We are provided 20 30 minutes. Generally present for 15 20 allowing 5 minutes to field questions. UCCWA member Ben Moline will work with John Winterton to add UCCWA slides to the presentation. The presentation PowerPoint needs to be given to the Commission two weeks before the meeting. The call-down list and household hazardous waste programs are elements included in the past. Four slides are a good number of slides for UCCWA to present.

Member Updates

Standing Items:

- LRE Regulatory Bulletin (Jessica DiToro) –The memo with links was provided in the meeting packet. A review of the highlights relevant to UCCWA was presented. Request to include in the next update the status on the periphyton issue, specifically downstream of wastewater plant outfalls. Recommend treatment plants take photos of this periodically. There is a small growing season. Only 3 or 4 photographs would need to be taken. This is attached algae on rocks, etc., not a plant. Mostly it is an aesthetic standard with a short growing season. One sample can be pulled by the Division and used to be put on the monitoring and evaluation list.
- Clear Creek Watershed & Forest Health Partnership Update (Diane Kielty) CCWFHP is preparing for the next field reconnaissance to the Empire cooridor of projects on October 18th. The Bakerville to Silver Plume corridor of projects (from the Wildfire Study) are in the scoping phase. The Partnership MOU is in place and the Partnership has their bylaws close to finalized.
- Integrated Watershed Management Plan (Ashley Giles) No report.
- CDPHE Stormwater Weblink: <u>Notice of Responsive comment period for Stormwater</u> Discharges Associated with Active and Inactive Mining Industrial Activity COR040000.
- Brad Benning has been working with Diane Kielty to develop a template and terms and conditions for UCCWA Small Projects Grants. This template will be sent to the membership for review.
- CSM will present the Missouri Creek Project at the November UCCWA meeting.
